# **Commission Terms of Service**



### I do not draw:

NSFW, Fetish Art, Furries, Mecha, Fan Arts

By purchasing my art services, you automatically agree to the following conditions. If there are any questions or concerns, Please contact me!

### Payment

- All payments via PayPal should be made in USD.
  - All payments should be made through invoice method. I will invoice you.
- After I have accepted the commission, I will place you in my waitlist. You can stay there for up to one week without paying, though I will only start working once full payment is made.
  - If one week passes with no payment, you may have to surrender your place to someone else wanting -and paying- to commission me.
- Please set your PayPal address to "No address needed" as the artwork will be digital.

### Refunds

- Once our negotiation is done and I start your commission, I cannot refund you the full amount. This is negotiable depending on the state of the commission.
  - If I have not started your commission, you can ask for a full refund. Depending on if I am in the sketch, line art, or colouring stage of your commission, a 75%, 50% and 25% refund can be given respectively.
- Once the work is completed I cannot refund it.

### Artist

- By commissioning me, you're purchasing my artist labor only. I retain all copyrights over my work, which include but are not limited to the right to distribute, reproduce or use the image as a sample for sales/ self-promotion, unless otherwise agreed upon.
  - I will respect your request to not publicly post your commission. No explanation necessary.
  - I cannot claim the Intellectual Property (The art that has your OCs in it) or reuse/resell the image for personal and commercial projects. Unless agreed upon.
  - I reserve the right to reject your commission proposal without question. This includes if you did not follow the rules for said order.

### Commissioner

- Once a piece is commissioned, you may use it for any personal use that you please, including but not limited to icons, signatures, wallpapers, themes, and personal site display.
  - You retain the rights to the Intellectual Property. All artwork containing your OCs I cannot profit from, and will not use in my own projects. But I still may use it as examples of my work to show other potential clients and for similar things.
  - You may not claim the work to be your own, edit or set it up for redistribution. You may not use it for any external projects, commercial or non-commercial unless agreed upon.
  - If you are looking for something to redistribute, reproduce, use for your project(s), as an ad, for a video, to resell at conventions etc. Speak to me for information on royalty fees.
    - If you are not sure whether your request counts as personal, feel free to ask me about its intended

#### Procedure

- After payment is received: I sketch, line art, and color depending on your commission type.
- I will keep you updated with WIPs.
- I will post the work when I have finished. I'll also send the file to the e-mail address linked to your PayPal account.
- Entire work could take up to 1-2 weeks to be completed.
- Please let me know if I have made any mistakes. Any changes that you want me to make because of a redesign or anything else that was not due to an error of mine may not be free; and depends on the complexity of the change.
